Privacy conditions

Under Article 13 3 23 of D. Lgs. 196/2003, Article 97 L. 633/41 and Article 10 c.c., I hereby declare that I have read the privacy policy regarding the use of my image and information and I express my consent processing them from Ser.In.Ar. Forlì-Cesena Soc.Cons.p.A. and third parties involved in the services of *Foodomics2020* and the sending of communications from the Organizing Committee of *Foodomics2020*.

Under D. Lgs 196/2003 and further modifications regarding the “Personal Data Protection Code” and the legislation on image rights, we would like to inform you that personal data released directly and spontaneously a tour offices, or sent by fax or through online forms in our website www.serinarpayments.it, or by email, will be processed by Ser.In.Ar. or third parties involved in the conduct of services of *Foodomics2020* and in the sending of communications from Ser.In.Ar and the Organizing Committee of *Foodomics2020*.

Information concerning the processing of personal data and image

D.Lgs 196/03 protects the confidentiality of personal data and dictates a series of duties to anyone processing personal data of other subjects. One of the most important duties dictated is that all the interested parties need to be informed and their consent needs to be obtained. The processing of personal data will be based on the principles of propriety, lawfulness and transparency, and the protection of personal privacy and rights.

According to what is above stated and to the Article 13 of D.lgs. n.196/2003, we inform you that:

1) The information you provided will be used for these reasons:

- Any operative, management or marketing need, to guarantee you to participate to the event *Foodomics2020*
- Execution of duties and compliances (administrative, accounting, fiscal, etc.) determined by current legislation.

- Management of the technical support service regarding the participation to the event *Foodomics2020*
 - Management of external collaborations
 - Addition of your person and activation of the services related to the event *Foodomics2020*
 - Provision of marketing services, including direct marketing, event organization, personal newsletters, DEM and invites to events from Ser.In.Ar. and the Organizing Committee of *Foodomics2020*, either in paper or digitally, manually and/or by electronic or automatic means.
 - The user is personally responsible for the authenticity of the information and data provided and published in the network and it will be his/her responsibility to complete, modify, update, delete such data by writing to amministrazione.serinar@criad.unibo.it.
- 2) The provision of personal data is discretionary. If data is not provided and/or if the consent to its processing is not given, this will cause together with the failure to participate at the present event, the inability to receive any material regarding the various initiatives and/or invites to events;
 - 3) Communication with third parties does not exempt them to provide their policy and ask for consent. We clarify that, apart from communication to subjects whose ability to access to data is recognized by law, by dispositions from Authorities, data could be communicated to the Organizing Committee of *Foodomics2020* and eventual sponsors of this initiative.
 - 4) The title holder of the personal data processing is Ser.In.Ar. Forlì-Cesena Soc.Cons.p.A., Viale Filippo Corridoni, 18, 47121 Forlì. The Person in Charge to replying to the interested subject is the President in charge, residing by the Holder to apply the Privacy Policy. Data can be processed by subjects qualified as in charged or appointed, in the scope of the promotion of events or initiatives. Moreover, data can be communicated to societies and consultants from IT and/or accounting and/or fiscal and/or legal fields, to teachers of courses in which the user participates and, also in indirect and accidental ways, to hosting companies with which the holder has a relationship to regularly fulfill the corporate purpose.
 - 5) The processing of data is pursued through IT and paper supports by the holder and the specifically appointed subjects, guaranteeing that, anyhow, data will be processed according to D.Lgs 196/2003 and later modifications. Data is kept in paper and IT archives and the minimal security measurements required by law are guaranteed, together with the ones suitable to guarantee the adequate protection of the processed data.
 - 6) According to the Art. 7 of D.Lgs. 196/03, in particular, the participant has the right to obtain the confirmation of the existence or not of personal data regarding him/her even if not registered yet; of the origin of the personal data; the indication of the scopes and means of data processing; indication of the logic applied when the processing is done through electronic instruments; the identification of the holder, the persons in charge and subjects or other categories of subjects to whom data can be communicated or who could be informed of data being in charge or appointed; the update, change or integration of data; the deletion, anonymous transformation or block of data if the legislation is violated; proof that the processing mentioned in the previous point were communicated, also in their content, to the people whose data was communicated or widespread, apart from the case in which this task is impossible or requires means which are out of proportion in relation to the protected right; has the right to object: for lawful reasons to the processing of personal data regarding his/her person; to the processing of data regarding his/her person for the sending of advertisement or direct sale material or for marketing research. In any moment, by contacting the Person in charge for the replying to the interested subject in the following point, the participant can claim his right to the holder of the processing.

- 7) Personal data of the interested subject, such as images collected during the conference *Foodomics2020* to which the interested subject takes part are processed and used only to obtain material used for the documentation of the activity carried out by the Holder. Image property rights are intended as the personal individual rights to demand that his/her image is not widespread, exhibited or published without his/her consent and out of conditions mentioned by law. According to what is above mentioned and to art. 97 L. 633/41 and art. 10 c.c., we inform you that:
- Ser.In.Ar. is authorized to used photographic material and/or videos shot during the conference *Foodomics2020*. This photographic and/or video material could be freely used by all the communication activities by the Organizing Committee
 - It is forbidden to show and/or copy and/or publish this material when this can harm honor, reputation, and respectability to one's person.
